TCISAA "Friend of the Industry" PATROL Pass Program

***purpose:**

the TCISAA "Friend of the Industry" Patrol Pass program enables any active patroller to ski or snowboard for **FREE** at any member ski/snowboard area, **ANYTIME** throughout the season. (Pass provides a lift ticket, one per day, for the pass holder only. The passes are photo I.D.'d and are not transferable or refundable.)

***eligibility:**

any active patroller. Each pass application must be signed by the pass applicant, your patrol director and an area manager before processing.



***cost/season:**

pass price is **\$125.00** and is valid **Nov. 1 - end of season**. Only 100 passes will be issued each season—on a first received, first issued basis. Passes will be sold throughout the season until the 100 limit is met.

send application & digital photo by email. Patrol director & area manager can email their approval, it will be copied to your form.

Your pass will be sent to you within 1 week after receipt at our office.*

*(To avoid delay, be sure to fill out application completely, include all required signatures, your photo & check or credit card info.) **Your pass cannot be processed without a photo. Do not send a previously laminated photo, these cannot be processed. Your pass is a form of ID. Do not send a photo where your face cannot be clearly—ie: wearing sunglasses, a hat, etc...**

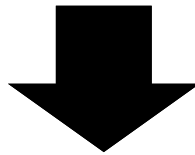
